**ETS Workshops**

**Faculty Orientation and Awareness Workshop**

This session is a thorough introduction to the *Praxis II* tests. Participants will explore factors that contribute to success for candidates taking licensure tests and resources available to both faculty and students. The participants will examine the kinds of questions that appear on the tests. Working together, participants will identify strategies candidates can develop for success in *The Praxis Series* tests and methodologies faculty and administrators can use to assist their students. Participants will have access to ETS documents that provide critical information about the tests, as well as the methods for using the information to better prepare their teacher candidates and those currently teaching.

**ETS Presentations**

**Standards, Accountability and Flexibility: Americans Speak on No Child Left Behind Reauthorization**

ETS's seventh annual public opinion poll, *Standards, Accountability and Flexibility: Americans Speak on No Child Left Behind Reauthorization*, reveals that parents, teachers and administrators strongly support No Child Left Behind (NCLB) reauthorization, despite limited knowledge about the law's provisions. They also favor greater flexibility in assisting students and schools struggling to meet high standards and call for increased funding for poorly performing schools to make adequate yearly progress.

The survey also shows that a majority of adults and parents think the 50 sets of state standards and tests should be replaced with one set of national standards and tests. English-language learners should be given more time to learn the language before they are pushed to learn the core curriculum at grade level.

**America's Perfect Storm: Report Has Converging Forces Threatening Our Future**

Three powerful forces; inadequate literacy skills among large segments of the population, the continuing evolution of the economy and the nation's job structure, and an ongoing shift in the demographic profile of the nation, powered by the highest immigration rates in almost a century are creating a "perfect storm" that could have dire consequences for our nation, according to a report by ETS.
