Connie Pollard reported data regarding Speech/Language therapists and Social Workers whose certificate expiration dates are past the 1/1/08 deadline to acquire a master's degree; she presented the final list of tests set for a 1/23-25/07 standards setting study panels; she reported that Title II Higher Ed Act report was completed for the 2005-06 school year; she met with WEA president Kathryn Valido and will attend their 12/1-2/06 meeting; she will attend the SBE meeting 11/15/06; she met with Joe Simpson, WDE and discussed Highly Qualified and the need for PTSB and WDE to have a seamless working relationship; she met with WDE personnel

regarding coaching, tutors, and highly qualified data; she reported that PTSB and NCATE partnership has not expired, with a special note of thanks to Kay Persichette and Pat McClurg; she was especially excited to report that WDE, through their Teacher Quality Enhancement grant, will fund an entirely new website for PTSB estimated at \$10,000 - \$20,000; she attended the NBTC advisory board meeting; she noted PTSB will begin keeping additional data regarding type and numbers of permit applications processed; she surveyed other states to determine which ones are using the HOUSSE and which ones accept a content major equivalent to "highly qualified" status for secondary and middle level teachers; she attended the NASDTEC mtg 10/17-20/06 in Baltimore; she reported that the school nurses have expressed a concern regarding PTSB acceptance of online certification for 1st Aid/CPR; she noted that rubrics were processed and letters sent verifying HQ status (middle level and social studies) as a follow-up to the extension Natrona #1 obtained from WDE to use the HOUSSE rubric; and she will meet with WY Education Association 01/27-28/07 and Wyoming Association of School Personnel Association 01/25/07.
