RULE CHANGES

• Chapter Two- Fee Changes

- Nish Goicolea explained why the fee raises are needed and why the fees must be entered into our rules. Nish Goicolea reminded the board members they voted on raising the fees on April 19, 2021. Discussion ensued that it was discovered the fee scale was not in the PTSB rules and this is a requirement; therefore, the fees must go through the promulgation process.

- Chapter Seven Coaching Endorsement
 - Nish Goicolea explained the new proposal for Coaching Endorsement and that PTSB staff has worked closely with the Wyoming Coaching Association regarding these changes. The only suggestion the WCA had was to allow for a grace period for all Assistants Coaches to obtain the requirements for Head Coach. There was a robust discussion regarding this topic. There was discussion on creating a subcommittee as it concluded this change needs to be examined further before the change is made.
- The PTSB Coaching subcommittee will include Dan Mayer, Brian Brisko, and Mike Hamel.

This discussion will continue at the October board meeting.

DIRECTOR'S REPORT

- Nish Goicolea explained the financial statements.
- Nish Goicolea provided an update on the staff and our recent B11 request to make our Office Assistant position a permanent state position rather than an "at-will" position.
- Nish Goicolea provided information on PTSB's recent FBI audits, indicating the agency passed both audits and was described as a model agency.
- Nish Goicolea provided an update on the agency's telework policy, which includes two full-time employees being permanently remote and a hybrid telework schedule due to downsizing of office space.
- Nish Goicolea provided information on the NASDTEC conference she and Assistant Director Brendan O'Connor attended in Savannah, GA. Nish mentioned many states are seeing an increase in discipline and some of the same issues PTSB is seeing with licensing. PTSB staff's next conference is in October for NASDTEC PPI Conference in Oklahoma City, OK.
- Assistant Director Brendan O'Connor provided information on AAQEP being recognized by CHEA. This is excellent news for the University of Wyoming as they have a membership with AAQEP.
